FGL International S.p.a., as data controller, hereby informs you that, pursuant to Article 13 of the EU Regulation 679/2016 on the protection of personal data (hereinafter Regulations), in order to establish and implement ongoing contractual relations, it is in possession or may subsequently become aware of information concerning you.

1. Type of personal data processed

The following personal data may be processed: personal and tax data, contact details, bank details and other administrative or commercial data needed for the purposes indicated below.

2. Purpose of the processing

The data will be processed for the following purposes: compliance with legal obligations and performance of the contract to which you are party, fulfilment of obligations towards the financial administration of the State, accounting and administrative management, management of existing business relationships and possible litigation.

3. Legal basis

The legal basis of the processing is the performance of the contract and the need to fulfil the obligations required by current legislation.

4. Provision

The provision of the required information is mandatory to fulfil legal and contractual obligations, therefore the refusal to provide it will make it impossible for the undersigned to perform the contract or to carry out correctly all the obligations provided for in point 2.

5. Storage times

The data will be kept for the period of time necessary to pursue the purposes indicated above and, in any case, not beyond the terms provided for by specific legal obligations.

6. Recipients of personal data

The data will be processed by appointed staff, duly instructed and operating under the authority and responsibility of the Data Controller.

Some of the information may be disclosed to the following subjects:

Public bodies (Revenue Agency, Tax Offices, etc.);

Legal or advisory practices to which the Company has given a specific mandate;

Service and maintenance companies of computer systems or providers of computer storage systems;

Other entities or companies carrying out activities instrumental to the purposes indicated above.

The data referred to in paragraph 1 above will also be communicated to the company Lapi Group S.p.a., as a service company within the corporate group, for administrative and accounting purposes. 7. Data subject's rights

We also inform you that, with regard to the said data, you can exercise the rights provided for by CHAPTER III of the Regulation at any time. In particular, you have the right to ask the Data Controller for access to the data concerning you, their rectification or erasure, the integration of incomplete data, the restriction of processing; to receive data in a structured, commonly used format readable by an automatic device; to object entirely or partially to the use of the data; and to exercise the other rights acknowledged by the applicable regulations. These rights can be exercised by writing to the address below or by e-mail to the following e-mail address: privacy@fglinternational.com. Pursuant to Art. 77 of the Regulation, moreover, you have the right to lodge a complaint with the Data Protection Authority if you believe that the processing infringes the aforementioned Regulation.
